When exercising equine, an employee of Red Bell Run must be in attendance.

_____ I agree to fully uphold confidentiality. I will preserve the confidentiality of the horses, other volunteers, information and the organization. If I disagree with something, or have questions regarding policy or procedures, I will speak to management ONLY. I will not participate in slanderous conversations. I agree to report any unsafe condition, accidents, concerns or uncomfortable social situations to management ONLY. If my concerns cannot be resolved, and I decide to resign, I will still respect all confidentiality and will be held to this agreement.

_____ I agree to keep photos of equine off my personal social media unless it is a positive perception. I understand each of the equine at Red Bell Run is at a certain level of rehabilitation and care. I understand some equine cannot be posted on any public forum/social media or discussed in the general population and will be sure to enquire as to which equine may not be shared on social media. I will not benefit financially from the use of any photos or images of equine residing at Red Bell Run and that all photos I have taken or using my likeness will become property of Fishin Machine LLC/Vineyard and The Sanctuary at Red Bell Run.

_____ I agree and acknowledge all clothing and accessories should be appropriate for working with equine and suited to a variety of weather conditions. Footwear must be appropriate and safe for working around equine. An equestrian or work boot, hiking boot or sturdy walking shoe is appropriate.
